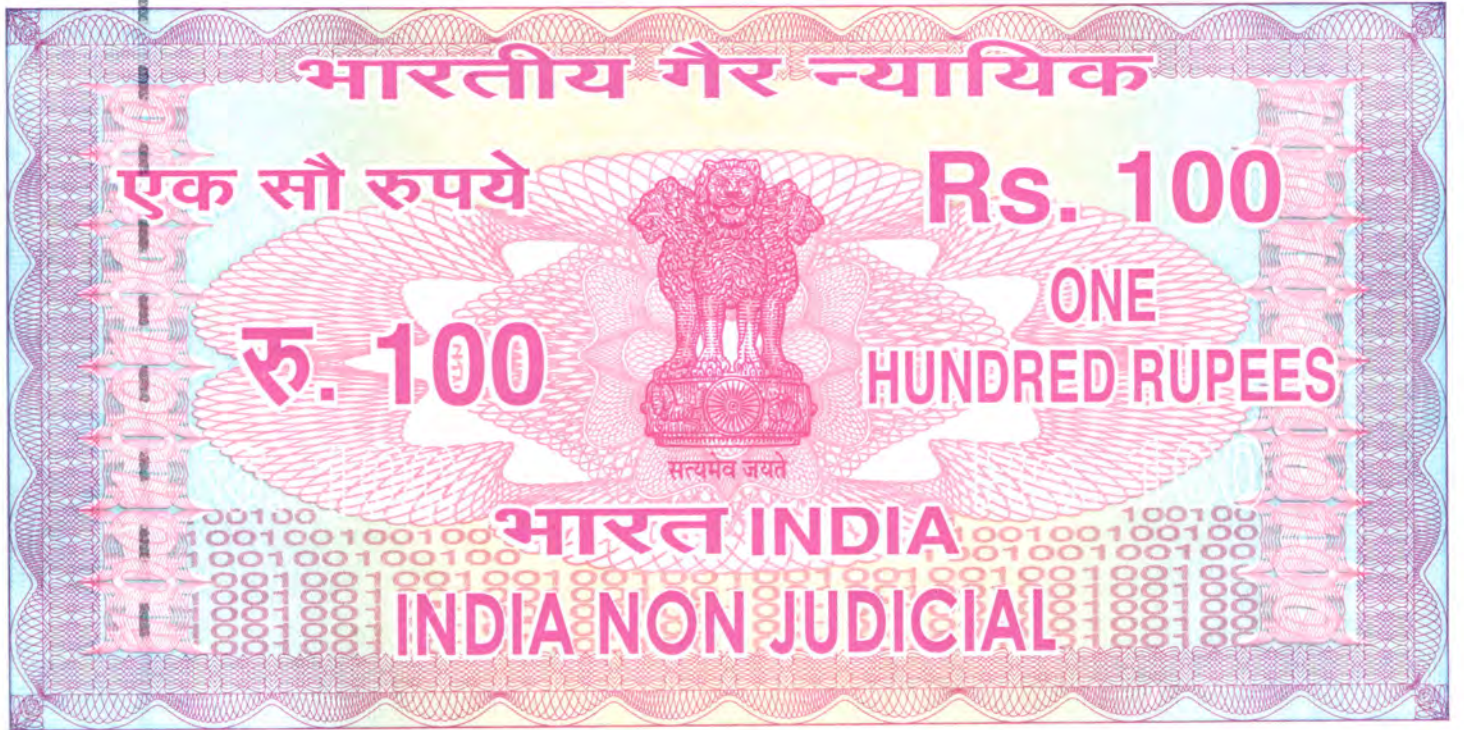
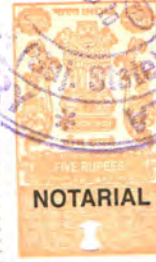

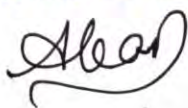
2. the said land is free from all encumbrances.

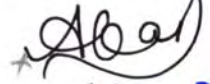

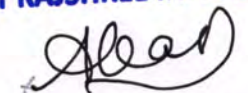
