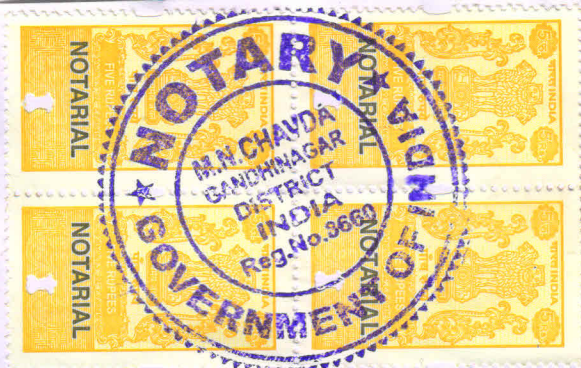

7.
