PART PLAN SHOWING LOCATION AS PER TOWN PLANNING SCHEME

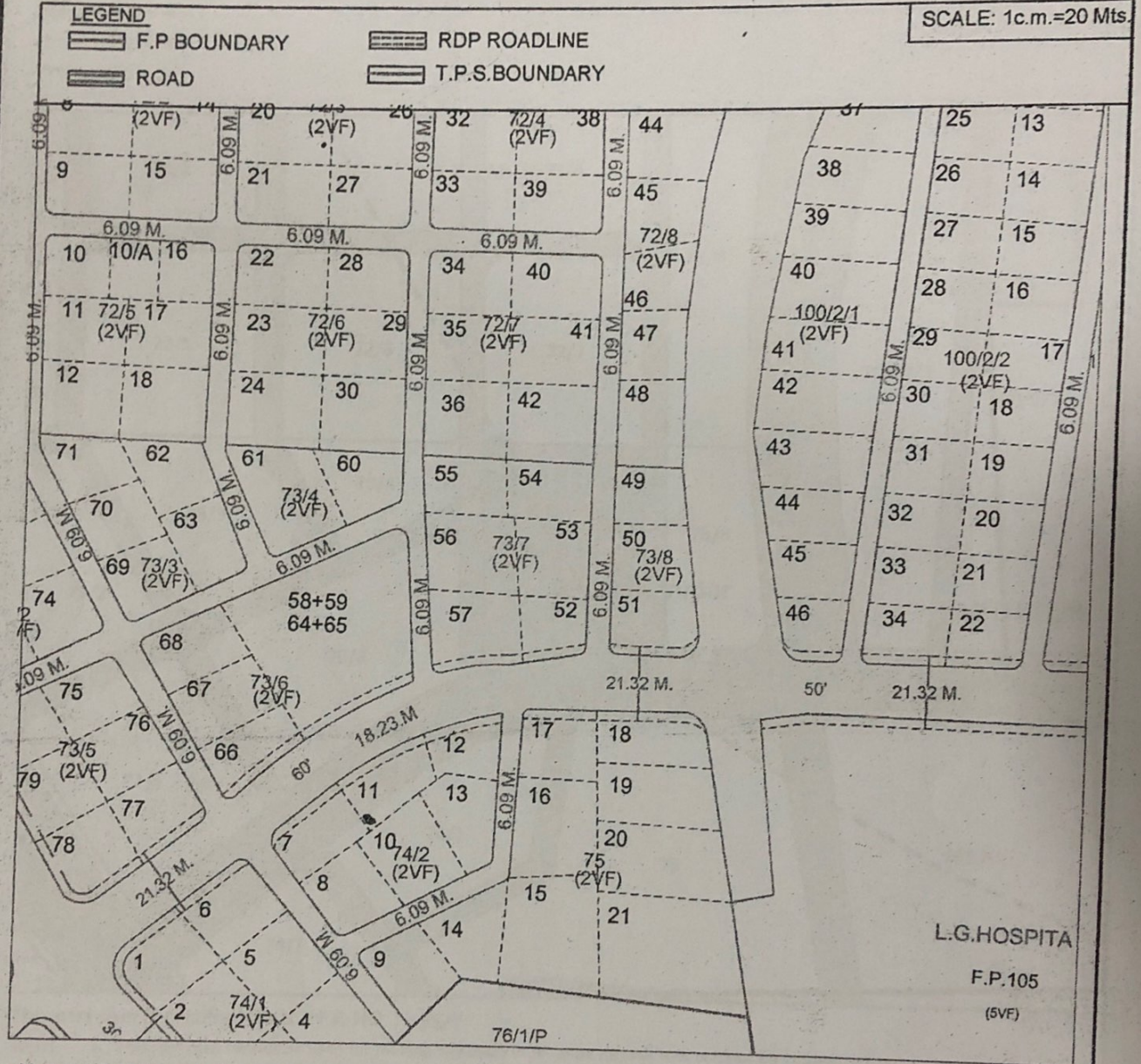

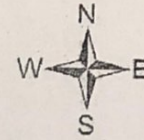

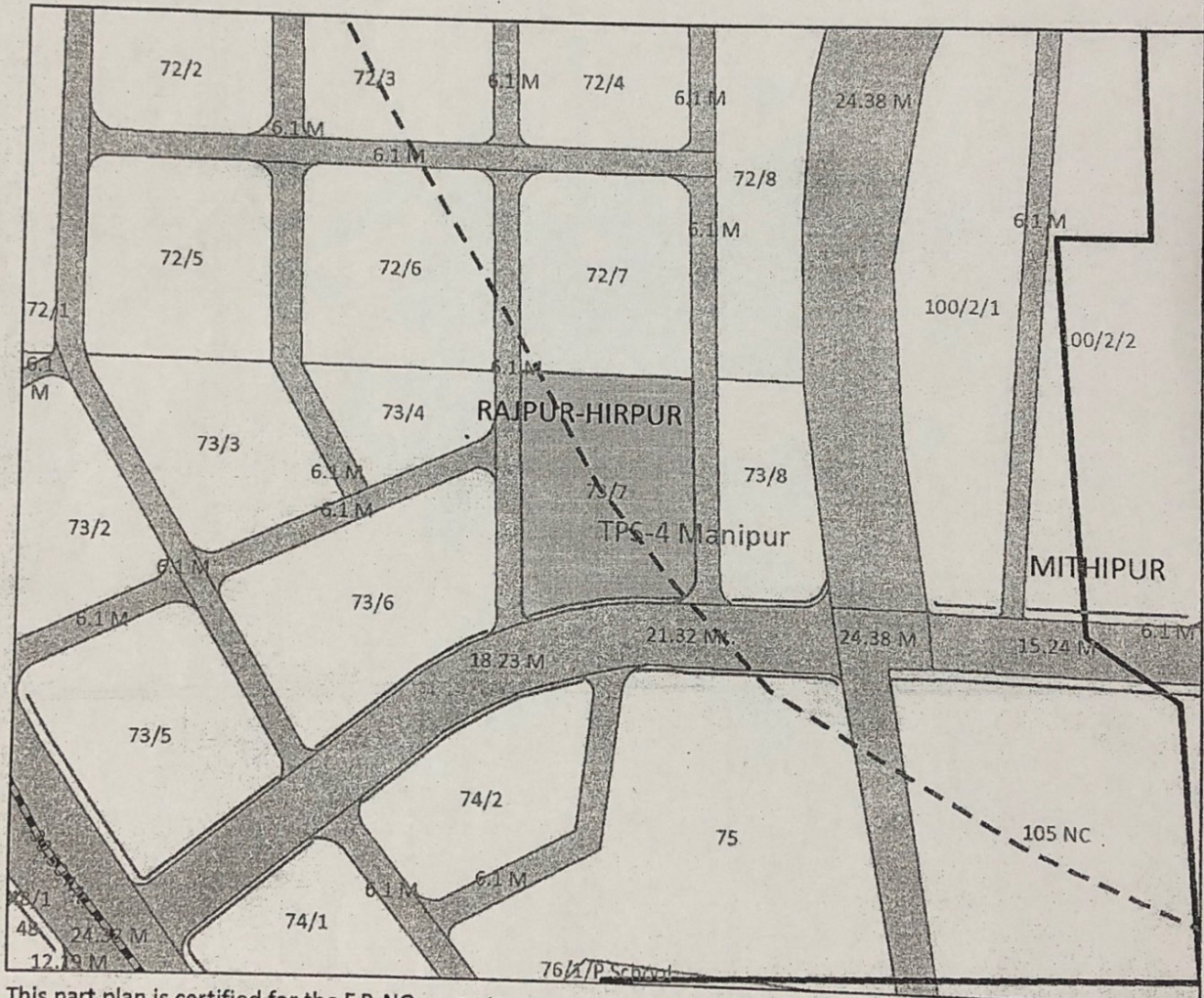
