Balances of Sundry Debtors / Creditors and Unsecured Loans / Advances are subject to confirmation. (3). In respect of payments by chq we have to state that it is not possible for us to verify whether the payments in excess of Rs.20000/35000/-, have been made otherwise than by account payee cheque or bank drafts, as the necessary evidence is not in the possession of the assessee. (4). In respect to expenses of the nature referred to in section 40(a)(ia) incurred during the year, we have carried out test check and during our verification wave found no amount is disallowable u/s 40(a)(ia). (5). Audit has carried on test Check Basis. (6). The assessee is involve in the business of development and construction of real estate housing project at various sites and considering the nature of inventory required it is practically infeasible to maintain stock register for day to day activity and valuation as on year ended has carried by partners and we relay on that valuation. (7) In Respect of Expenditure Of Personal Nature it is practically infeasible to Check the Payment made is for personal basis or not accordingly the partner given the certificate and we relay on that certificate. (8) With Respect to applicability of section 43CA or 50C of Income tax act it is not possible for us to verify whether transfer took place for less than stamp duty value or not as assessee has involve in the business of the Property Development so partner given the certificate of the value of the property sold above stamp duty value and we relay on that certificate.
