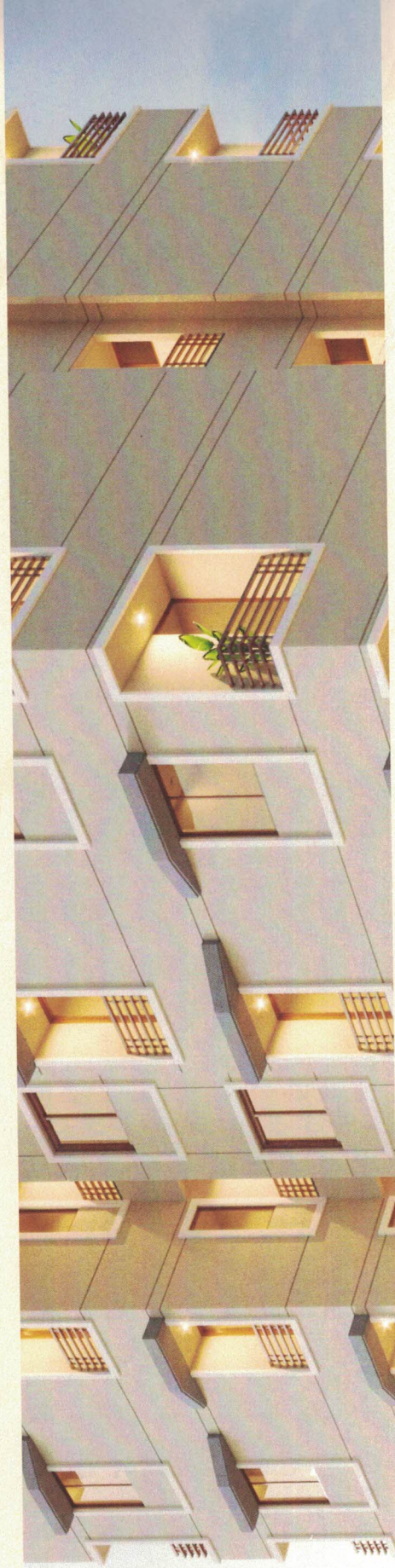

□ DOORS & WINDOWS

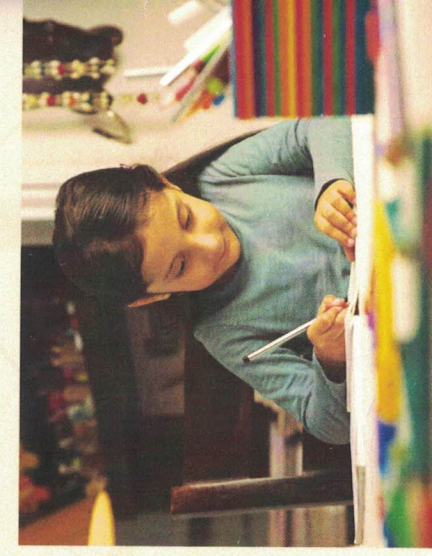
Decorative main door with standard safety lock & fittings. All other internal doors are flush doors with lamination and Aluminum section windows with safety grill.

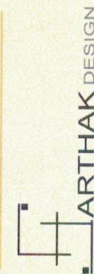
