As the company has not carried on any business during the year there is no revenue from operation. Further the net loss after tax for the relevant year has increased from Rs 24593.54 to Rs 36054

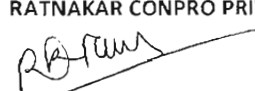
