ii) in the case of the Income and expenditure account, of the *Surplus of the assessee for the year ended on that date.

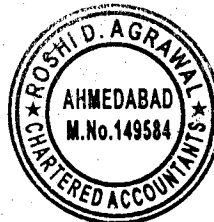
