Report on the Audit of the Financial Statements.

Opinion

We have audited the financial statements of **SNEH DEEP REALTY PRIVATE LIMITED** ("the Company"), which comprise the balance sheet as at 31st March 2021, and the statement of profit and loss, (*statement of changes in equity*) and notes to the financial statements, including a summary of significant accounting policies and other explanatory information. (here in after referred to as "the Standalone Financial Statements").

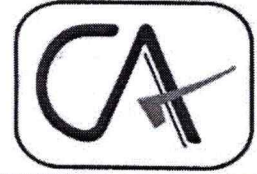
Our opinion on the financial statements does not cover the other information and we do not express any form of assurance conclusion thereon.

- (d) Its turnover for the year is not more than Rs.10 Crores during the year.

- (a) We have sought and obtained all the information and explanations which to the best of our knowledge and belief were necessary for the purposes of our audit.
- (b) In our opinion, proper books of account as required by law have been kept by the Company so far as it appears from our examination of those books
- (c) The Balance Sheet and the Statement of Profit and Loss, (the Statement of Changes in Equity) dealt with by this Report are in agreement with the books of account.
- (e) In our opinion, the aforesaid financial statements comply with the Accounting Standards specified under Section 133 of the Act, read with Rule 7 of the Companies (Accounts) Rules, 2014.
- (f) On the basis of the written representations received from the directors as on 31st March, 2021 taken on record by the Board of Directors, none of the directors is disqualified as on 31st March, 2021 from being appointed as a director in terms of Section 164(2) of the Act.
