I, Rameshbhai K. Patel duly authorized by the promoter of the proposed project do hereby solemnly declare, undertake and state as under:

3. That the time period within which the project shall be completed by promoter is March-2019.

8. That promoter shall take all the pending approvals on time, from the competent authorities.
9. That promoter has furnished such other documents as have been prescribed by the rules and regulations made under the Act.
