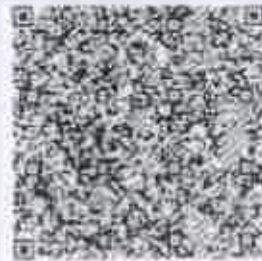

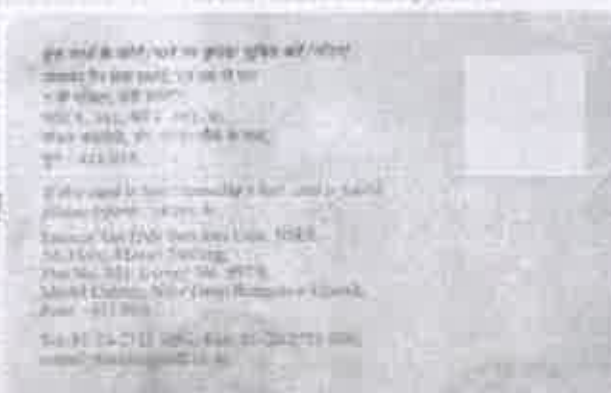

- Permanent Account Number (PAN) facilitate Income Tax Department linking of various documents, including payment of taxes, assessment, tax demand, expenses, matching of information and data maintenance & retrieval of electronic information etc. relating to PANholder's tax and non-tax activities in order to facilitate generation of report of income flows at source and T.
