Your site is located at a distance 7502 mts from ARP and lies in the grid L9 of the published CCZM of Ahmedabad airport. The Permitted top elevation for this grid is 115 mts.

Since the requested top elevation 109.24 mts in AMSL is below CCZM permitted top elevation, the NOC for height clearance is not required from Airports Authority of India.
