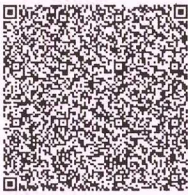

1. I/ We have a legal title to the land on which the development of Smart Ghar - 4 TPS 6 Rajkot FP 161 (528 Units) is to be carried out;

a legally valid authentication of title of such land along with an authenticated copy of the agreement between such owner (promoter) and developer agency for development of the real estate project is enclosed herewith.

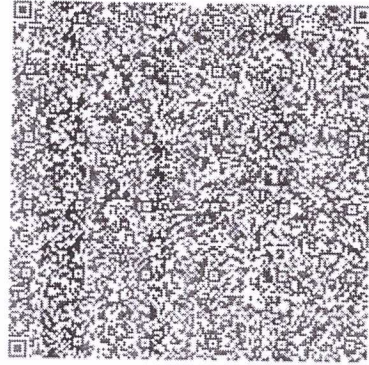

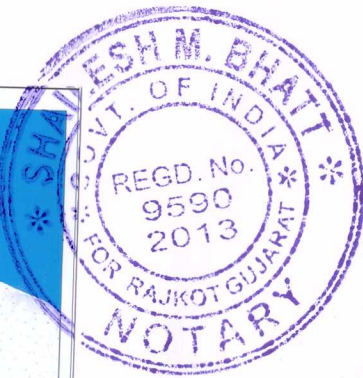
