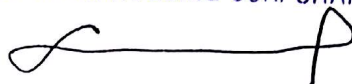
1. That I, SURESHBHAI K. PATEL / promoter have / has a legal title to the land on which the development of the project is proposed.

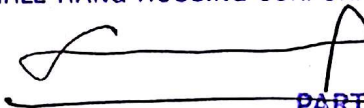
