TYPICAL FLOOR PLAN (4th, 5th & 6th)

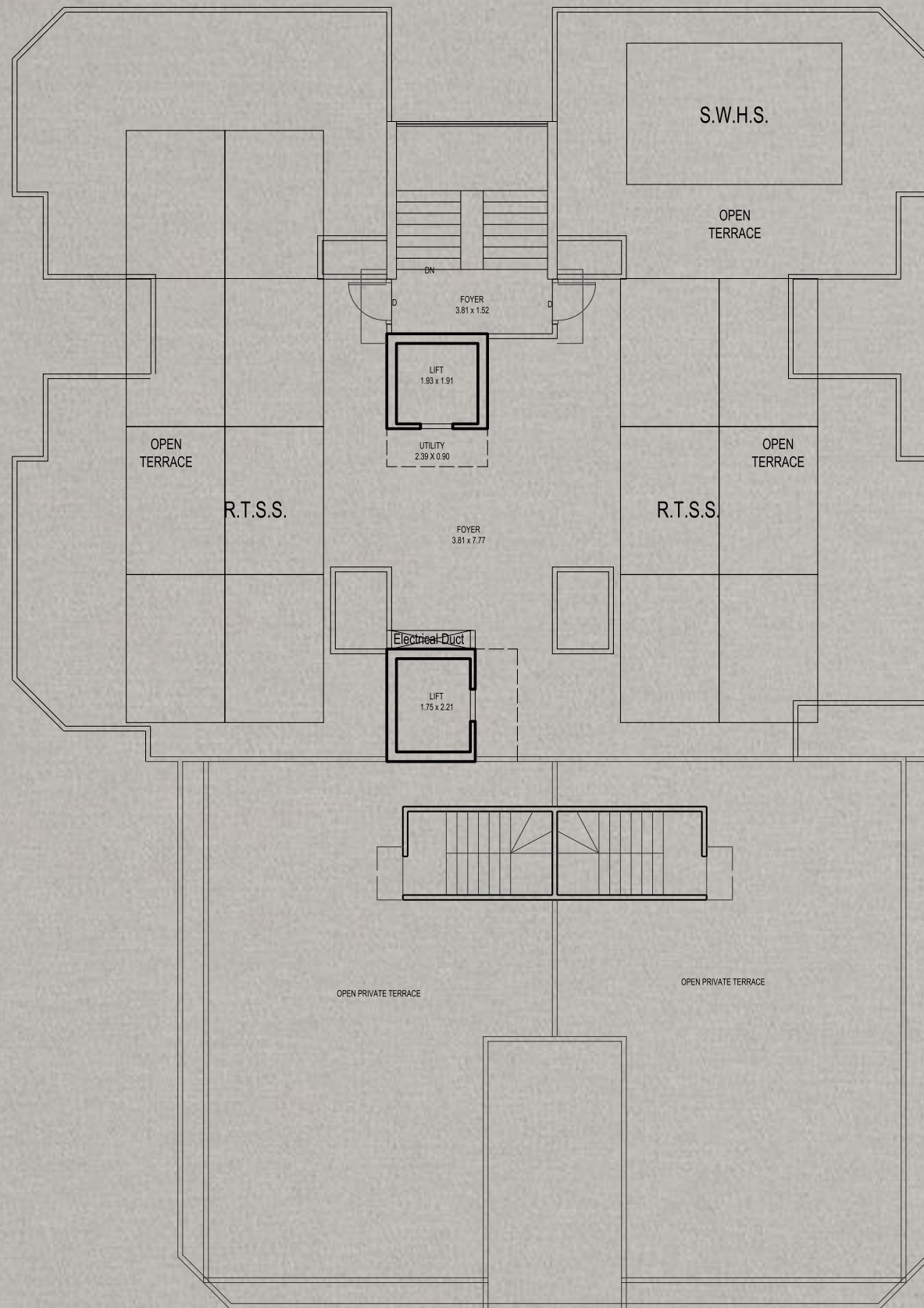
