To this intent, we have caused the searches of the available records of the concerned office of the Sub Registrar Assurances for a period of last Thirty Years and have perused and scrutinized copy of the documents /papers / revenue records as are made available to us and believing the

HISTORY OF SURVEY NO. 166/1 and 166/2

- 4.1 It has been observed by us that, the land bearing Survey No. 166 / 1 and 166 / 2 was owned and occupied by Vahji Bechar prior to the Year – 1955 meaning thereby he was the occupier of the said land within the meaning of Sub Section 16 of Section 3 of the Land Revenue Code and said fact is corroborated by 7/12 abstract of the Year – 1951-52.

Note : We have examined that, the original owner of the said land was Pathaji Lakahji but Pathaji Lakhaji had mortgaged the said land with Vahji Bechar and hence, the name of Vahji Bechar was entered as occupier.

- 4.2 It has been observed by us that, the owner of the said land namely Pathaji Lakahji was mortgaged the land bearing Survey No. 166/1 and 166/2 with Vahji Bechar by Oral Agreement as is expressly corroborated and evidenced by certified mutation entry No. 186 dated 07-04-1935.
- 4.3 It has been observed by us that, the land bearing Survey No. 166/1 and 166/2 was declared as “Fragment Land” in accordance with provision of Sections-5 and 6 of “THE BOMBAY PREVENTION OF FRAGMENTATION AND CONSOLIDATION OF HOLDING ACT-1947” as is expressly corroborated and evidenced by certified mutation entry No. 386 dated 19-08-1951.
- 4.4 It has been observed by us that, the provisions of THE BOMBAY PREVENTATION OF “FRAGMENTATION AND CONSOLIDATION”

OF 1947 were made applicable to the land in question and the consolidation scheme of Mouje Village - Chharodi was sanctioned by the Settlement Commissioner of Director of land record Gujarat State Ahmedabad vide notification dated 10-04-1961 and said scheme was published on page No. 729 and 730 of gazette of government of Gujarat Part - 1 on 06-04-1961 and according to the said consolidation statement, land bearing Survey No. 166/1 admeasuring Acre. 0-16 Guntha with Pot Kharabo admeasuring Acre. 0-1 Guntha total admeasuring Acre. 0-17 Guntha and Survey No. 166/2 admeasuring Acre. 0-13 Guntha was given Block No. 230 and its area was fixed to the extent of admeasuring 3035 sq. mts., including the land of pot kharaba and allotted to Pathaji Lakhaji as is expressly corroborated and evidenced by certified mutation entry No. 546 dated 05-08-1963.

- 4.9 It has been observed by us that, the joint holder of said land namely Aataji Ramaji Thakor had died intestate on 14-06-2005 leaving behind him his lineal descendants as (1) Reshmaben Aataji Thakor, (2) Vinaji Aataji Thakor, (3) Javanji Aataji Thakor and (4) Jayantiji Aataji Thakor and hence, their names were brought on the revenue record upon succession right as is expressly corroborated and evidenced by certified mutation entry No. 1446 dated 26-09-2005.

Note : We have examined that, aforesaid mutation entry which is certified by the competent authority except the Block No. 230.

- 4.10 It has been observed by us that, the joint holder of said land namely Somaji Pathaji had died intestate on 11-05-2003 and his

4.11 It has been observed by us that, the joint holder of said land namely Anandiben Kedarmal had died on 23-03-2008 leaving behind him his lineal descendants as (1) Mimiben Kedarmal, (2) Shantiben Kedarmal, (3) Mohiniben Kedarmal, (4) Sohiniben Kedarmal, (5) Lilaben Kedarmal, (6) Girjaben Kedarmal, (7) Savitriben Kedarmal, (8) Gopiben Kedarmal, (9) Vasudev Kedarmal, (10) Manubhai Kedarmal and (11) Rameshchandra Kedarmal and hence, their names were brought on the revenue record upon succession right as is expressly corroborated and evidenced by certified mutation entry No. 2159 dated 29-10-2010.

4.12 It has been observed by us that, the joint holder of the said land namely Anandiben Kedarmal died on 23-08-2008 but before her demise, she executed her last unregistered Will and according the provisions of the said Will, her share in the land bearing Block No. 230 was inherited by (1) Vasudev Kedarmal, (2) Manubhai Kedarmal and (3) Rameshchandra Kedarmal as is expressly corroborated and evidenced by rejected mutation entry No. 2160 dated 29-10-2010.

4.13 It has been observed by us that, the Deputy Collector, Dascroi Prant, Ahmedabad passed order bearing No. RTS / Appeal Case No. 502 / 2011 dated 09-01-2012 and inter alia directing to certify mutation entry No. 2160 by setting aside order of the Mamlatdar, Dascroi rejecting the mutation entry No. 2160 as is expressly corroborated and evidenced by certified mutation entry No. 2288 dated 12-01-2012.

4.14 It has been observed by us that, the reconstitution of Ahmedabad City and Daskroi Taluka of Ahmedabad District by Resolution No. PFR/102011/275/L/1 dated 17-03-2012, two different Taluka of Ahmedabad Taluka are formed as Ahmedabad (East) and Ahmedabad (West) and accordingly, Chharodi Village was covered within the Taluka Boundaries of Ahmedabad city (west) as is expressly corroborated and evidenced by certified mutation entry No. 2325 dated 03-05-2012.

4.15 It has been observed by us that, vide circular of the Revenue Department, Sachivalay Gandhinagar the Taluka Ahmedabad City(East) and Taluka Ahmedabad City(West) in Revenue district Ahmedabad were reorganized and new Taluka were formed and accordingly land of Revenue village-Chharodi is now made part of Taluka Ghatlodiya.

4.16 It has been observed by us that, the joint holder of said land namely Vasudevbhai Kedarmal had died intestate on 3-08-2021 leaving behind him his lineal descendants as (1) Sarojben Wd/o Vasudevbhai Kedarmal (2) Sunitaben Vasudevbhai (3) Minaben

Vasudevbhai (4) Shilpaben Vasudevbhai (5) Manishaben Vasudevbhai (6) Piyushbhai Vasudevbhai and hence, their names were brought on the revenue record upon succession right as is expressly corroborated and evidenced by certified mutation entry No. 3379 dated 27-09-2021.

- 4.17 It has been observed by us that, Vasudevbhai Kedarmal had died intestate on 3-08-2021 and but before his demise, he executed his last Notarized Will before Notary Advocate on 20/5/2021 and according the provisions of the said Will, his undivided share 1/3 part in the land bearing Block No. 230 was inherited by Piyush Vasudevbhai Agrawal on the basis of Affidavit & Copy of Certified of will as is expressly corroborated and evidenced by certified mutation entry No. 3412 dated 14-12-2021.
- 4.18 It has been observed by us that, the provisions of the Gujarat Town Planning and Urban Development Act-1976 were made applicable to the land bearing Block No. 230 admeasuring 3035 sq.mts., by merging into Draft Town Planning Scheme No. 36 (Chharodi - Tragad) is given Final Plot No. 113 and its area is fixed to the extent of 1821 sq. mts., and Form-F is issued in accordance with the Provision of Rules 21 & 35 of the Gujarat Town Planning and Urban Development Rules-1979 enacted under the said act.
- 4.19 It has been observed by us that, the holder of said land had submitted an application to the District Collector, Ahmedabad for obtaining non-agricultural use permission and on consideration

of said application, the District Collector, Ahmedabad passed order bearing No. 1344/07/17/049/2022 dated 11-3-2022 and granted non-agricultural use permission to the said land bearing Block No. 230 admeasuring 3035 sq. mts., for Mutli -purpose and gave it Final Plot No. 113 admeasuring 1821 Sq. Mtrs in T. P Scheme No. 36 (Chharodi - Tragad) in accordance with THE PROVISION OF SECTION-65, 66, AND 67 OF LAND REVENUE CODE-1879 AND THE PROVISIONS OF RULES -100,101 OF THE GUJARAT LAND REVENUE RULES-1972 and as is expressly corroborated and evidenced by certified mutation entry No. 3462 dated 11-3-2022.

4.20 It has been observed by us that, owners of the said land namely 1) Manubhai Kedarmal 2) Rameshchandra Kedarmal 3) Piyush Vasudev Agrawal sold and conveyed non agricultural land bearing Final Plot No. 113 admeasuring 1821 sq. mts., T. P. Scheme No. 36 (Chharodi – Tragad) comprised of Block No. 230 admeasuring 3035 sq. mts. to ARTHAM REALTY LLP by a registered sale deed which was registered before Sub-Registrar on 18/4/2022 with serial no. 8702. This land bearing Final Plot No. 113 admeasuring 1821 sq. mts., T. P. Scheme No. 36 (Chharodi – Tragad) comprised of Block No. 230 admeasuring 3035 sq. mts. was mutated in the name of ARTHAM REALTY LLP and as is expressly corroborated and evidenced by certified mutation entry No. 3492 dated 4-5-2022.

4.21 It has been observed by us that, non agricultural land bearing Final Plot No. 113 admeasuring 1821 sq. mts., T. P. Scheme No. 36 (Chharodi – Tragad) comprised of Block No. 230/paiki 2

5. **Mutation of the name / s of the land owner / s in revenue records:-**

On bare perusal of latest Village Form No. 7, the names of **ARTHAM REALTY LLP.** is appearing as occupier of the said land as defined in Sub Section 16 of Section 3 of Land Revenue Code.

6. **Searches :**

6.1 We have caused the searches of the available records through our search clerk for last 30 years from the office of the concerned Sub-Registrar of Assurances and on bare perusal of said Sub-Registry record, we have not found any objectionable matter.

6.2 **Perusal of the revenue record as are made available to us :**

Nothing objectionable found in the copies of the revenue records as are produced by the land owner / s to us.

7. **Special Observation :**

7.1 It has been observed by us that, land under investigation was declared as fragment land at the relevant point of time but now the Bombay Prevention of Fragmentation and Consolidation of Holding Act, 1947 has been amended vide act No. 14 /2012 by

the legislature and according to the said amended act it is not forbidden by law to sell the land which was declared as fragment land in the past before the act was amended. Moreover, the revenue department of State Government issued circular bearing No. AKT / 1087 / 1415 / J (Part-04) dated 10-04-2013 and issued instruction for taking action in the context of amendment and as per the provision of Para-2 of said circular also, now it is not forbidden by law to transfer the land which was declared as fragment land in the past to lawful agriculturist of Gujarat State.

- 7.2 It has been observed by us that, When the land was sold by sale deed bearing 1604 dated 28-02-2005, the said land was ancestral property in nature and hence, it was essential to obtain confirmation of legal heirs of vendor but it is a fact that, considerable time about sixteen years elapsed after said sale transaction and it is pertinent to note that, as per the provision of Article 59 of Indian Limitation Act, the suit for cancellation of sale deed can be filed within three years from the knowledge about it but the doctrine of notice contained in Section 3 of Transfer of Property Act is important and especially the principle of implied or constructive notice is required to be construed and as per the explanation 1 of Section 3 of Transfer of Property Act, a person is said to have notice about the registered sale deed from date of its registration and mutation entry is also a public record and one has constructive notice about it. Moreover, the Hon'ble Supreme Court of India has established the principle of law laid down in the case of Dilboo By Lrs & Anr. Vs/. Dhanraji

and others, 2500 7 SCC 702 the person is deemed to have knowledge about sale transaction from the date of its registration and the Hon'ble High Court of Gujarat has also laid down the principle in the case of Becharbhai Zaverbhai Patel V/s. Jasubhai Shivabhai Patel 2013 (1) GLR 398 that the person is deemed to have knowledge about sale deed from the date of its registration and such as on bare perusal of Article 59 of Indian Limitation Act, statutory provision of Section 3 of Transfer of Property Act and above referred case laws, it is crystal clear that, sale deed can be challenged within three years from the date of its registration.

In the instant case, sale deed was executed in the Year – 2005 and hence, inference may be drawn that, the legal heirs of vendors were deemed to have knowledge about said sale deed and said sale deed has not been challenged inspite of lapse of about sixteen years and hence, any probable claim on their part will suffer from legal infirmity and same shall be hardly sustainable in the eye of law and such as said sale transactions are deemed to be lawful and valid.

- 7.3** It is pertinent to note that, we have examine available sub registry record i. e. for seventeen years of the land under investigation but it is pertinent to note that, entire sub registry record i. e. the sub registry record of thirty years are not available in the concerned government office i. e. the sub registrar of assurances and hence, it is not possible to examine the sub registry record of the entire thirty years of the said land.

7.4 We have examined that, in view of mutation entry No. 186 dated 07-04-1935, it transpires that, the said land was mortgaged by Vahji Bechar in the Year – 1935 and it appears that, the entry in respect of reduction of mortgage might not been entered in the revenue record and such as considerable time of about eighty five years elapsed and after consolidation of the scheme at village Chharodi, is no any reference of Vahaji Bechar in the revenue record and in view of the provisions of Limitation Act also the matter suffers from time limit.

8. Conclusions :

In view of what is stated in forgoing paras and the observations made by us, we are of the legal opinion that, the title of the land owners to their land more particularly described in Schedule hereunder written is clear, marketable and free from encumbrances and reasonable doubts subject to :

1. Fulfilment of terms and condition laid down in N. A. Order and the provisions of the Gujarat Town Planning and Urban Development Act, 1976 and rules made there under and Laws applicable and in force to effect legally and properly sale, transfer or any other transaction with respect to the said land.

9. Certificate about legal opinion :

We opine that, **ARTHAM REALTY LLP.** has valid, clear free from any charges or reasonable doubts and marketable title to the said land subject to the observations made in all forgoing paras and especially the observation made in para-8 above.

8.1 It has been observed by us that, the land under investigation was converted into old tenure land for non – agricultural use by the competent authority after recovering the amount of premium and said land has been already been into non – agricultural land in accordance with the Provision of Section 65 of Land Revenue Code and it is well settled position of law that, the laws relating to agricultural land are not applicable to non – agricultural.

8.2 It has been observed by us that, as reflected in mutation entry No. 1574 dated 31-08-2006 (1) Galaji Somaji Thakor, (2) Lasiben Somaji Thakor, (3) Hlraben Somaji Thakor, (4) Manguben Somaji Thakor, (5) Shakuben Somaji Thakor, (6) Baijaben Somaji Thakor, (7) Shardaben Ramaji Thakor, (8) Manguben Ramaji Thakor had waived their rights, but not by registered document and it is pertinent to note that, the Hon'ble Supreme Court in the case of Kale V/s. Deputy Director of Consolidation, reported in AIR 1976

SC 807 made observation that, even a family arrangement may be oral and in each case no registration is necessary. Moreover, the Hon'ble High Court of Gujarat also made observation to that effect, in case of Anandiben Jamabhai Patel V/s. State of Gujarat and Other. Moreover considerable time of about ten years elapsed after releasing their right from the said land. Moreover, Supreme Court of India had delivered Civil Appeal No. 784 / 2010 on 01-05-2019 in case of Thulsidhara and others V/s. Naryanappa and others and laid down the principal of laws and in the case of family partition and released of right from agricultural land, registration is not mandatory and the Government of Gujarat has also issued such instruction by issuing circular.

- 8.3 It has been observed by us that, When the land was sold by sale deed bearing 13921 dated 17-12-2007, the said land was ancestral property in nature and hence, it was essential to obtain confirmation of legal heirs of vendor but it is a fact that, considerable time about thirteen years elapsed after said sale transaction and it is pertinent to note that, as per the provision of Article 59 of Indian Limitation Act, the suit for cancellation of sale deed can be filed within three years from the knowledge about it but the doctrine of notice contained in Section 3 of Transfer of Property Act is important and especially the principle of implied or constructive notice is required to be construed and as per the explanation 1 of Section 3 of Transfer of Property Act, a person is said to have notice about the registered sale

deed from date of its registration and mutation entry is also a public record and one has constructive notice about it. Moreover, the Hon'ble Supreme Court of India has established the principle of law laid down in the case of Dilboo By Lrs & Anr. Vs/. Dhanraji and others, 2500 7 SCC 702 the person is deemed to have knowledge about sale transaction from the date of its registration and the Hon'ble High Court of Gujarat has also laid down the principle in the case of Becharbhai Zaverbhai Patel V/s. Jasubhai Shivabhai Patel 2013 (1) GLR 398 that the person is deemed to have knowledge about sale deed from the date of its registration and such as on bare perusal of Article 59 of Indian Limitation Act, statutory provision of Section 3 of Transfer of Property Act and above referred case laws, it is crystal clear that, sale deed can be challenged within three years from the date of its registration.

In the instant case, sale deed was executed in the Year – 2007 and hence, inference may be drawn that, the legal heirs of vendors were deemed to have knowledge about said sale deed and said sale deed has not been challenged inspite of lapse of about thirteen years and hence, any probable claim on their part will suffer from legal infirmity and same shall be hardly sustainable in the eye of law and such as said sale transactions are deemed to be lawful and valid. However, it would be advisable to obtained confirmations of legal heirs of vendors and confirmations of original owners.

Note : We have examined that, said sale deed bearing No. 13921 dated 17-12-2007 by power of attorney holder and hence, the confirmations of original owners was necessary but considerable time about thirteen years elapsed and hence, the said transaction was deemed to be valid in view of the Law of Limitation.

- 8.4 It is pertinent to note that, we have examine available sub registry record i. e. for seventeen years of the land under investigation but it is pertinent to note that, entire sub registry record i. e. the sub registry record of thirty years are not available in the concerned government office i. e. the sub registrar of assurances and hence, it is not possible to examine the sub registry record of the entire thirty years of the said land.
- 8.5 It has been observed by us that, the Hon'ble 7th Additional Civil Judge, Ahmedabad Rural passed order in Sp. Civil Suit No. 118/ 2007 considering the compromise pursis of the parties below Exh. 15 and according the said pursis, it is the duty of the respondent to execute the sale deed in favour of plaintiff of the said suit in the context of the Agreement to Sale dated 14-08-2006 and defendants have no objection if the relief is granted by the court and accordingly the decree was drawn and it appears that, the defendants of the said suit had executed sale deed bearing No. 13921 dated 17-12-2007 as per the order of the Hon'ble court.

8.6 We have examined that, (1) Laxmiben Somaji Thakor, (2) Hiraben Somaji Thakor, (3) Manguben Somaji Thakor, (4) Baijaben Somaji Thakor and (5) Shakuben Somaji Thakor had executed Deed of Power of Attorney in favour Galaji Somaji Thakor registered in the Office of the Sub Registrar of Assurances at Ahmedabad-2 (Vadaj) under Sr. No. 17005 dated 17-09-2010 but it is pertinent to note that, sale deed of the said land was executed on 17-12-2007 and hence, such power of attorney has no meaning and it is also fact that, said joint holders had released their rights at reflected in mutation entry No. 1574 dated 31-08-2006.

9. Conclusions :

In view of what is stated in forgoing paras and the observations made by us, we are of the legal opinion that, the title of the land owner /s to his land more particularly described in Schedule hereunder written is clear, marketable and freeform encumbrances and reasonable doubts subject to :

1. Fulfilment of terms and condition laid down in N. A. Order and the provisions of the Gujarat Town Planning and Urban Development Act, 1976 and rules made there under and Laws applicable and in force to effect legally and properly sale, transfer or any other transaction with respect to the said land.
2. Registered Confirmation of vendors in view of Sale Deed bearing No. 13921 and confirmation of legal heirs of vendors being obtained.
