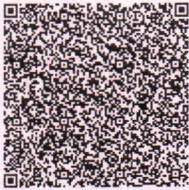
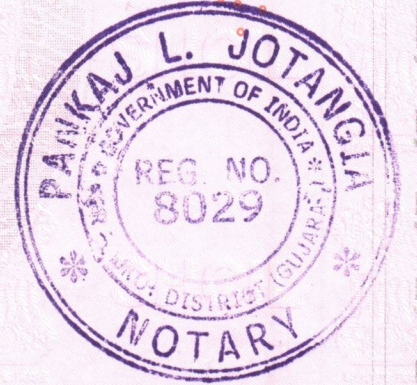

3. That the said land is free from all encumbrances.

10. I/we have furnished such other documents as have been prescribed by the rules and regulations made under the Act.

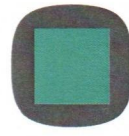
