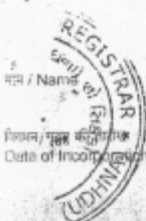

- Permanent Account Number (PAN) facilities the Income Tax Department linking of various documents, including payment of taxes, assessment, tax demand, tax returns, matching of information and other information & retrieval of electronic information etc. relating to a taxpayer.
- स्थायी लेखा संख्या (PAN) एक कर्तव्य से अधिक विभिन्न दस्तावेजों को जोड़ने में आयकर विभाग को सहायक होता है, जिसमें करों के भुगतान, आकलन, कर कागज, कर की मांग, कर की रिपोर्ट, जानकारी के मिलान आदि शामिल हैं।
- Quintessence of PAN is now mandatory for several transactions specified under Income Tax Act, 1961 (Refer Rule 114B of Income Tax Rules, 1962) and other provisions, 1961 के तहत निर्दिष्ट कई लेनदेन के लिए स्थायी लेखा संख्या (PAN) का उपयोग अब अनिवार्य है (आयकर विभाग, 1962 के नियम 114B, का संदर्भ दें)
- Now, anyone who has more than one PAN is against the law & may attract penalty of up to Rs. 10,000.
- अब, जो व्यक्ति अपना एक से अधिक (PAN) का रखता है उसका कानून, धारा 114B के तहत 10,000 रुपये तक का दंड भुगतान हो सकता है।
- The PAN Card enclosed contains Enhanced QR Code which is readable by a specific Android Mobile App. Keyword to search this specific Mobile App on Google Play Store is "Enhanced QR Code Reader for PAN Card".
