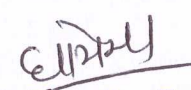

1. I/ We have a legal title to the land on which the development of Smart Ghar - 6 TPS 31 Rajkot FP 31/A, 31/B & 31/3 (1584 Units) is to be carried out;

AND

a legally valid authentication of title of such land along with an authenticated copy of the agreement between such owner (promoter) and developer agency for development of the real estate project is enclosed herewith.

2. The said land is free from all encumbrances.
3. The time period within which the project shall be completed by me/us by 30/06/2022.
